R26/10 PLANNING, TRANSPORT, PARKING & PATHS

a) **Core Strategy Final Plan**

The late arrival of paperwork defining the terms under which the plan should be considered meant that Cllrs deferred their comments until the next meeting.

b) **Changes to waiting restrictions in Ludlow Town Centre**

The final notice for, and a copy of, the traffic regulation order was **NOTED**.

c) **Urban and Rural Speed Limit and VAS Policies**

Cllrs **NOTED** the policies, and commented that Sheet Road was still a problem area. Cllrs were concerned that there were insufficient repeater speed limit signs to make motorists aware of the speed limit.

Members were in agreement that a speed camera would be an effective deterrent, although its presence would still need to be supported by repeater speed limit signs.

d) **West Midland SHA – The brief update note was NOTED**

e) **Dinham Lodge – A verbal report of the meeting was received from Cllr Wilcox.**

f) **New Structure of Meetings – This item was move to the beginning of the agenda.**

Cllr Martin Taylor-Smith explained the outline aims new pilot scheme, which could become a model 'Local Panel' for other market towns in Shropshire, to members of the Representational Committee. The main aims are to reduce the incidence of unnecessary meetings, and make most effective use of resources and to ensure an improved flow of data into meetings and the planning process.

Ian Kilby answered member's questions.

Cllrs asked that an effective system be put in place to deliver feedback from Shropshire Council to Town Council to enable Cllrs were able to see the process by which decisions had been made.

PROPSAL: Ludlow Town Council (LTC) Representational Committee (REP) meetings would take place once a month on the same day as Ludlow

Area Conservation Advisory Committee (LACAC) meetings, but at a later time. An officer from Shropshire Council would attend both meetings, and in due time, there may be agreement for certain types of applications to be filtered out of the meetings and delegated to Shropshire Council officers.

RECOMMENDED (unanimous)

That:-

- i. an officer(s) from Shropshire Council be requested to attend the LCAAC meeting.
- ii. the Chairman of Representational Committee also be invited to attend the LCAAC meeting.
- iii. the Shropshire Council officer(s) be invited to attend the later Representational Committee meeting.
- iv. the Chairman of LCAAC would be invited to attend the later Representational Committee meeting.

The objective being for Representational Committee Members and Members of the LCAAC to then make separate comments to Shropshire Council, but the process will have benefited from all parties receiving a much wider range of perspectives and professional advice.

RESOLVED (unanimous)

That Ian Kilby would draw up an outline proposal for training. The training session would take place at the next meeting on 16th March 2010.
