R/105 PUBLIC OPEN SESSION (15 minutes)

There were five members of the public present.

Mr Michael Smith of Brook Cottage, Fishmore Road, Ludlow 13/03862/OUT land off A49 Bromfield Road, Ludlow.

Mr Smith raised his concern over the outline application to develop the land off Bromfield Road. He provided Members with a plan of the area indicating where his property is situated. Mr Smith pointed out to Members the effect the development would have on the river flow and cause potential flooding.

Mr Smith acknowledged that the Council was not the principle planning authority and Mr Smith referred to article 8 of the Human Rights Act in relation to the responsibilities of Shropshire Council.

Article 8 Right to respect for private and family life

- 1. Everyone has the right to respect for his private and family life, his home and his correspondence.
- 2. There shall be no interference by a public authority with the exercise of this right except such as is in accordance with the law and is necessary in a democratic society in the interests of national security, public safety or the economic well-being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others.

Councillor Mold and Councillor Sheward entered the meeting at 7.07pm

Mr Tony Quint of 22 Friars Garden, Ludlow 13/03933/FUL Chapel Works, Old Street, Ludlow

Mr Quint informed members of the impact the proposed extension to the rear of the property and the impact it would have on properties at the rear of the site, Friars Garden. The extension would dominate the skyline and be approximately 10 meters from his property.

He has no objection to the development of the Chapel Works with the omission of the two higher level apartments.

R/106 LUDLOW'S UNITARY COUNCILLORS QUESTION AND ANSWER SESSION

Shropshire Council's Unitary Councillor Rosanna Taylor Smith, North appreciated residents concerns over the two developments they raised.

Chapel Works, Old Street, Ludlow

LCAAC has visited the site and commented on the application. This application requires careful consideration and she acknowledged that residents were not objecting to the change of use but to the impact the rear extension will have on properties in Friars Garden.

Land off the A49 Bromfield Road

Councillor Rosanna Taylor Smith said it is important that residents of Ludlow have the chance to comment on this application and that she has been monitoring the Shropshire Council website for updated comments especially comments from the Environmental Agency. We all appreciate there is a need for further housing developments that offer affordable housing but caution must be taken in flood plain areas. I have visited Mr Smith's property, Brook Cottage in the past when it has been flooded and saw the damage that was caused.
