## R/188 NATIONAL GRID GAS WORKS REPLACEMENT PROGRAMME

Mr Richard King Senior Construction Manager of Balfour Beatty and Mr Neil Bailey of Gas National Grid presented members with an outline of the proposed essential gas works in Ludlow.

- New Road
- Broad Street
- Bull Ring
- Castle Street
- Footpath beside Old Street B4361 Opposite Ludford Mill
- Glencoe Terrace
- High Street
- King Street
- Lower Broad Street
- Old Street
- Portcullis Lane
- Silk Mill Lane
- Steventon New Road
- Temeside

Mr King and Mr Bailey explained that the works were identified as essential by the HSE because of the combined factors of old metal pipes (legacy seed pipes) the properties had cellars and the town centre location. Mr King and Mr Bailey agreed with members that a meeting of businesses and organisations should be arranged in the New Year.

Balfour Beatty have not yet devised a detailed plan and estimated these would be completed in the next two months and then there is a statutory 90 days notice period to Shropshire Council before work could begin.

It is therefore unlikely that works could begin before June 2015.

Members expressed concerns that if the works estimated to take two months starting in June they would take place at the height of the tourist and festival season and the detrimental impact could bankrupt some of the local independent businesses.

Members asked that the following information / concerns should be address a a public meeting with town centre businesses:

- How can residents/businesses contact the customer care team?
- Level of compensation for business and clearly identified process?
- How and when will residents and business be informed of the planned works?
- Will there be any assistance for business and essential deliveries?

Ludlow's Heritage is also a key concern and members would like reassurance that:

- The structure of Ludford Bridge and the Broad Gate have been considered and works are undertaken in consultation with English Heritage?
- The timescale for the closing of Ludford Bridge would be kept to a minimum because it is a main route into the town from the South?

The chair thanked Mr King and Mr Bailey for their presentation.
