PF/77 REPRESENTATIONAL COMMITTEE RECOMMENDATIONS

The Chairman noted that the amendments to the Project Support Grant were practical and sensible, and thanked the Representational committee for their proposal.

Councillor Ginger added that there are a number of local small organisations that rely entirely on Project Support Grants. It would also mean that smaller core annual grants will be monitored in more detail annually.

RECOMMENDED (Unanimous GG/PD)

In line with the policy that all grants will be applied for annually:

- From April 2016, Representational Committee receives applications for grants of up to £300.00 to provide ongoing annual support to local organisations and one-off project support
- ii) The grant is renamed Annual & Project Support Grants
- iii) The criteria is amended to state that the purpose of the grant can be either a one-off project or support for an established local initiative
- iv) Representational Committee retains a budget of £2,000.00

PF/78 FAIRTRADE TOWN STATUS

Phillip Hume presented to members regarding Ludlow's relationship with the Fair Trade movement.

He stated that the principles of Fair Trade are very prominent within Ludlow businesses, and how encouraging it is to see this being advertised by traders more widely.

Philip talked to members about the benefits of Fair Trade to producers and their communities, and how Ludlow is considered to be one of the leading towns in the UK, having been one of the first in the country to be accredited with Fair Trade status.

He added that in order to retain this status, a review must be conducted every 2 years with progress and future planning being considered. Phillip stressed the importance of the Town Council to the movement, and proposed that a group is nominated so that ideas can be brought forward to Council in the future.

The Chair thanked Mr Hume for his presentation and for attending the meeting.

Councillor Ginger added that this was a positive move for Ludlow and that he supported the involvement of the Town Council.
