17. <u>FOLDGATE LANE DEVELOPMENT</u> (LUDFORD)

To consider the information from a Shropshire Council Planning Officer that:

Condition 10 of the outline permission requires that access from the A49 is constructed prior to any other development. The applicant Crest has reviewed this and concludes that given the steepness of the highway embankment it would not be possible for initial works to commence from the A49. This conclusion is supported by Highways England.

Accordingly Crest have entered into discussion with the planning and highway authorities to assess the feasibility of achieving an initial construction access via an 85m stretch of Foldgate Lane. This would be subject to appropriate safeguards including restricted hours of use, restrictions on type of traffic, traffic management and noise control measures etc. Access would revert to the A49 as soon as an appropriate means of access to the A49 had been achieved from within the site.

Crest have been advised that a formal variation to condition 10 would be required and there can be no guarantee that an application would succeed. To date no such

application has been submitted. If an application is submitted then it would be subject to a full planning consultation process.
