R152/08/09 PLANNING, TRANSPORT, PARKING & PATHS

- a) **Retendering of Local Bus Service Contracts** – Members raised three points they would like to be considered.
- (i) When buses break down, which seems to be quite frequently, the service suffers because there do not seem to be a reserve bus to continue the route.
 - (ii) Is it possible to notify travellers of breaks in service? If a passenger is expecting the bus at 10 past the hour, but it doesn't show up, so the passenger begins walking only to have the bus go past when they are walking between bus stops, which is very annoying.
 - (iii) The following changes to current bus services were proposed. Service 702 could become a dedicated town service, so that local do not receive a compromised service at peak times when the bus is full from the park and ride and unable to stop for locals.

Service 703 could operate as a dedicated park and ride service operating every 20 minutes, which would allow a small degree of flexibility to accommodate the 'hail and ride' aspect of the service. These changes would provide a better service for local residents and visitors to Ludlow.

- (b) **Broadgate Arch** - The proposed works to the Broad Gate Arch planned to commence on

Monday 9th March have been postponed. Shropshire County Council have been unable to gain Scheduled Monument Consent in time to start the works and will therefore have to reschedule the works probably until September because English Heritage require certain conditions to be met before they will give consent was **NOTED**.

(c) **Shropshire Bus** –Public Transport News March 2009 was **NOTED**

(d) **Road Closure** – The extension of the temporary order prohibiting traffic from proceeding underneath Broadgate Arch until 9th April 2009 was **NOTED**.
