R/184 PRESENTATION

Members received a presentation from Mr James Caird Chair of Ludlow Area Advisory Committee on the planning controls potentially available in conservation areas.

Mr Caird explained the three options that the Ludlow Town Council could follow to control some of the current issues within the conservation area.

- Planning Control
- Listed Building Control
- Advertising Control

As far as planning permission is concerned, Schedule 3 of General Permitted Development Order lists the developments that can be made without planning permission - known as permitted development.

Within a conservation area it is possible to apply to the Secretary of State (SoS) for an 'Article 4 Direction'. An article 4 direction is made by the local planning authority but requires approval by the Secretary of State. It restricts the scope of permitted development rights either in relation to a particular area or site, or a particular type of development anywhere in the authority's area.

The shortcoming of Article 4 for Ludlow conservation area is that there are few unlisted buildings to which it would apply, thus reducing its impact

<u>Advertisement consent</u> is required for all developments that are not either exempt or have deemed consent through the Advertisement Regulations which are complex and pretty lenient. The local planning authority may introduce an Area of Special Control (with SoS approval) which would reduce the scope of deemed consent to an extent.

<u>Listed Building Consent</u> is required for any 'alteration or extension [to a listed building] in any manner which would affect its character as a building of special architectural or historic interest'. Listed Building Consent is required in addition to planning permission and if both are required the two applications are usually handled together by the local planning authority. Listed Building control is already fully in force in the Ludlow conservation area.

Because of the very broad scope of the definition, in Ludlow, where most of the buildings are listed, this is the most effective tool for restricting inappropriate development and advertisements, through both permissions and enforcement.

- a) To consider ways of improving planning enforcement options in Ludlow's Conservation Area as described in the presentation earlier in the meeting.
 - i) To ask Shropshire Council Planning Authority to apply for an article 4 direction under article 4 of the General Permitted Development Order which enables the Secretary of State or the local planning authority to withdraw specified permitted development rights across a defined area.
 - **ii)** Request that Shropshire Council implement enforcement of Listed Building Control within the Ludlow Conservation Area.
- b) To consider approaching Shropshire Council's Street Scene Team to prevent illegal and / or improve notification of legal pavement closures and management of obstacles on the pavement.

- i) To request that Shropshire Council's Street Scene and Highways present a definitive map clarifying which areas of pavement are property of Shropshire Council highway.
- ii) To seek clarification of the procedure and regulations to prevent illegal and/ or improve notification of illegal pavement closures and management of obstacles on pavements
