# FC/361 FREEDOM OF THE TOWN

It was confirmed that although the Royal Welsh Fusiliers had been warmly welcomed by the town and had paraded in Ludlow to celebrate their 300<sup>th</sup> Anniversary in March 1989, the freedom of Ludlow had not been granted at this time.

Members raised concerns that there was no budget allocated to the event, however, it was felt that there was significant support in the local community and fundraising would be undertaken.

Members acknowledged that the event would be very important for Ludlow, and of interest beyond Ludlow, so the event should be well advertised when arrangements had been established. The timetable for the event will be largely dependant on The Royal Welsh.
