FC/402 RECOMMENDATIONS FROM POLICY AND FINANCE COMMITTEE

Boxing Club Funding

The Town Clerk introduced the report and explained that she had approached the Society of Local Council Clerks who had advised her that under Section 19 of the Local Government Act the Town Council could loan funds.

Councillor Perks stated that the project was a good example of localism but the phase after construction would still need guidance and suggested that a Working Group was formed. He continued by saying that Colin Richards, the Site Manager deserved praised for his work throughout the project.
