R/40 PLANNING, TRANSPORT, PARKING & PATHS

a) Proposed Pedestrian Zone

The Town Clerk introduced the proposed zone by Shropshire Council and demonstrated to the Committee the approximate size of the signage which would be used should the zoning go ahead.

The Mayor stated that signage should be kept to a minimum and expressed his concerns that it would not be just an undertaking of signage and but that this zone would need to be enforced. He reminded Members of the quantity of representations received at the Town Council from the public and traders regarding another pilot scheme by Shropshire Council recently and warned the Committee that this could be a repeat.

Councillor Rosanna Taylor-Smith was invited to speak by the Chairman and said that she was horrified to see the size of the signs that had been produced by the Officers. She explained that this proposal was being put forward following complaints received at the Local Joint Committees regarding traffic flow and parking. She mentioned a possible "shared space parking" which would produce less signage and vellow lines in the Town and stated that Shropshire Council were looking into this. The Mayor stated he was looking for Ludlow to have minimum linage and signage and the proposal would be far worse than having the van parked in Harp Lane for short periods during the day, whereas illuminated signs in the region of the Deli on the Square and Quality Square would have a detrimental impact on that location. When the Town Clerk stopped the film footage at the Buttercross and explained that there would be a sign to the right of the Buttercross, all Members expressed their concerns on the impact to visual amenity in that area as the Buttercross view from the King Street approach is one of the most photographed prominent views in Town and it would be destroyed by a metre high illuminated traffic sign. Similar comments were made in relation to the sign at the Buttercross end of Harp Lane in close proximity to Bensons shop. A Member commented that the proposal could be destructive to Ludlow's reputation and heritage and that any signage should be discreet.

Members had due regard to the comments from the Signage Group and the Civic Society's request to rationalise signage on the approaches and in the Town and felt that their reservations expressed on the 24th August 2010, remained in that:-

- i) the proposed signs are too large and obtrusive within the historic environment of Ludlow:
- ii) the amount of signage proposed is excessive compared to the "problem" it sought to remedy;
- iii) the map is inaccurate it does not depict the dropped curb in High Street and incorrectly depicts yellow lines on both sides of College Street when they are only on one side.

RESOLVED DD/LC (unanimous)

That the Council strongly objects to this proposal for the above reasons.

(b) AONB or National Park Designation Proposal

The Town Clerk introduced this proposal and after some discussion the Members agreed that on initial reading the proposal was acceptable.

The Committee reviewed the written explanation and reviewed the plans provided by Shropshire Council. A member stated that the motorcycle bays should be painted onto the road in Mill Street. Members did not understand what was proposed in Broad Street as there was no plan or explanation and asked the Clerk to seek clarification and to email the Members with the response.

That the waiting restrictions be supported other than the west side of Broad Street until a plan and details have been provided.

- ii) The Clerk should write to Sally Newman Kidd, Graeme's widow, formally notifying her of this and explaining that this is considered by the Council to be a fitting tribute to Graeme for his tireless work for the Council.
