## R33 GRANTS, PLANNING, TRANSPORT, PARKING & PATHS

(a) Camp Lane

RESOLVED (5:1:0) SMc / DD

That 3no cast iron bollards similar to existing fixed nearby should be installed for the frontages of no's 9 to 11, but there should be no additional road markings on Camp Lane.

## (b) Parking in Ludlow Town Centre

Members considered the proposals from residents of Mill Street. Members received a verbal report from the Market manager. He explained that the nature of market trading means that goods are transported to and from the market each

day and some trader would need large vans to accommodate the quantity and / or size of goods for sale. The success of the Ludlow's award winning market has meant that more traders are coming to Ludlow. The market traders were aware of the problem themselves, but the current situation does not allow a viable alternative because Shropshire Council has restricted parking in castle Street Car Park to a maximum of four hours, which means using the car park is not an option for traders. Members were also informed that on street parking congestion in Mill Street on Sundays was not helped by parking charges in the Castle Street car park whilst street parking was free.

Members discussed parking and issues relating to signage for the park & Ride, signage for parking in Ludlow and the Park & Ride Bus Schedule.

## RECOMMEND (5:1:0)

That a meeting be arranged between Ludlow Town Councillors, Shropshire Councillors and officers to discuss issues relation to parking in Mill Street / Castle Street Car Park, signage for the Park & Ride and other car parks and Park & Ride Bus Schedules.
