#### R25 GRANTS, PLANNING, TRANSPORT, PARKING & PATHS

#### (a) Shropshire Council Planning Support <u>RECOMMENDED</u> (unanimous)

To reject the imposition of the Shrewsbury Planning Liaison model on Ludlow for the following reasons:

(i) There has been no consultation

(ii) Shropshire Council has not produced a report, analysis or reasoned argument to support the imposition of the Shrewsbury Planning Liaison model in Ludlow

#### Members do not support the new structure, which they believe will be to the detriment of Ludlow for the following reasons:

(i) The Planning Liaison model has been trailed in Shrewsbury, which is a very different place to Ludlow and there is no evidence that the model is transferable.

(ii)The described purpose of the Planning Liaison Group is to discuss 'significant per-application proposals and to provide feedback on service related issues'

This statement raises a number of very important issues:

(a) How will significant be defined? Will the significance of an application be measure in terms of financial impact on the area, aesthetic, conservation, or number of dwellings?

(b) Who will decide what is significant for Ludlow?

(c) Will Listed Building Consent matters relating to existing dwellings be considered significant?

(d) The pre-application stage raises concerns because full supporting material and facts may not be available, so the value of considering an application at this stage seems doubtful.

(e) Service related issues are perhaps not the same as material planning considerations and fuller explanation and clarification is required.

(iii) The purpose also states that 'Developers will be invited to present potential development schemes for feedback.' Ludlow is a small town, and while there is some scope for larger scale developments, the majority of planning applications are individual changes to existing properties. Would this type of application be considered by the Planning Liaison Group?

(iv) The mandate of the group is described as non-political, but the Chairman of the Planning Liaison group will be a Shropshire Councillor, which means that the agenda will be set by Shropshire Council at a level that has many political implications. Whereas if the group is able to vote for a chairman from within the membership, and the agenda is set with officers as it seems is currently the case in Ludlow, the agenda will more closely reflect the planning applications that are deemed significant by residents and other interested local parties.

(v) Providing advice and support for Shropshire Council policy and planning processes is a useful activity, but does not seem to have the local small scale emphasis that is necessary in Ludlow.

Although Ludlow Town Council does not support the introduction of the proposed Planning Liaison Group on Ludlow. Members are supportive of including a wider range of perspectives and interests into the existing Conservation Area Advisory Group and extending the remit to consider listed buildings outside the conservation areas.
