R/11 APOLOGIES

Apologies for absence were received from Cllr Aitken & Wilcox

R/12 DECLARATIONS OF INTEREST

In accordance with the terms of the Local Authorities (Model Code of Conduct) (England) Order 2007 issued under Section 51 of the Local Government Act 2000 Members declared interests as follows: -

Clir Hunt 11//00624/ADV Uses Travis Perkins as a supplier at work

Clir Hunt 11/02351/FUL the father of a relative by marriage may still own the building, although this was unclear because they were currently not in communication.

R/13 PUBLIC OPEN SESSION (15 minutes)

There were six members of the public present.

Mr Wood, Resident of Ludlow spoke in objection to application 11/02447/COU

He stated that the change of use would be undesirable in a residential area. It would create cooking smells, late night noise and increase litter in the area. The take-away would be a magnet for school children. St Leonard's Church yard could

be misused by customers. He asked if members thought that a Fish & Chip shop should be the first thing visitors see when they enter Ludlow?

Pat Hansen, resident of Ludlow spoke in objection to application 11/02447/COU

She stated that the development would have a detrimental impact to an area close to the river. She said there are already ten takeaways in Ludlow and this one was unnecessary. There would be parking problems and the road was dangerous at this point.

Linda Barker, resident of Ludlow spoke in objection to application 11/02447/COU

She stated that the development would cause loss of residential amenity, light pollution, parking problems and because of the location of the building on a bend on the road it would be dangerous. She also mentioned that there may be a problems with anti-social behaviour such as vomit on the path if the take-away is used after the pub.

Mrs Wood, resident of Ludlow spoke in objection to application 11/02447/COU

She stated that take-aways often attracted vandalism and the site was an a dangerous bend. There was a possibility that traffic would be tempted to turn round at the traffic lights which would be dangerous, and the surrounding streets would experience higher volumes of traffic.

Mrs R Taylor-Smith spoke on behalf of the neighbouring property to application **11/02351/FUL**

The resident to the left had side of the development asked that members give consideration to the impact of the development of the second floor bathroom window.

R/16 PLANNING APPLICATION COMMENTS

11/02031/FUL 40 Wheeler Road, Ludlow RESOLVED (unanimous)

LTC comments: This application was deferred to this meeting in order to allow time for any complaints from neighbours to be received. None were received, and therefore the Committee has no objection to the application.

11//00624/ADV Travis Perkins, Parys Road, Ludlow Business Park **RESOLVED (unanimous)**

LTC comments: Cllrs considered the two planning considerations relevant to this application, which are highway safety and amenity. It was agreed that the banners do not impede driver's vision and the area is a well established trading area. Members advised that for the benefit of the business and consideration of residents in the area the advertising banners should be well managed and tidy in appearance.

Objection

LTC comments: Members were concerned that the banners would have an adverse impact on the visual amenity of the listed building and the surrounding area.

11/02423/TCA Land opposite, Cliffdene, Dinham, Ludlow **RESOLVED** (unanimous)

LTC comments: Members felt that the trees made a positive contribution to the character of the area

11/02447/COU Honda Equipe, Coronation Avenue **RESOLVED** (4:0:1)

Objection

LTC Comments: Members objected on the following grounds:

Highway Safety – the site is on a dangerous bend

Detrimental change of character – The surrounding area is currently a quiet residential area, especially in the evenings.

Injurious of visual amenity – the area has a number of listed buildings and is one of the main entrances to Ludlow

Noise and nuisance - an increase in traffic, general noise levels and introduction of extracted cooking smells would cause nuisance to neighbours which would be detrimental to the amenity of the surrounding area.

R17 GRANTS, PLANNING, TRANSPORT, PARKING & PATHS

(a) Local Development Framework Summary Update

RESOLVED (unanimous)

That members noted and were in general agreement with the revised summary. Members asked that a reference to the fact that more detailed information is available in the Ludlow Town Plan.

A consultation of this nature raises complex issues that will impact on the future of Ludlow. Members are aware of the difficulties in getting very detailed responses from consultations, but they would encourage Shropshire Council to endeavour to extract as much detail as possible from primary information sources, so that the subsequent reports are as detailed and comprehensive as possible.

(b) Temporary Road Closure

(c) Temporary Parking Restrictions

RESOLVED (unanimous)

To note the temporary parking restrictions – Corve Street 25th July – 30th July.

(d) Friends of Shropshire Hills <u>RECOMMENDATION</u> (unanimous)

That Policy & Finance Committee approve an annual subscription of £50 so that Ludlow Town Council can become an organisational member of Friends of the Shropshire Hills AONB.

Representational Committee is referring this matter to Policy & Finance because the funding is not for one-off project, but a continuing annual subscription to an organisation, which should therefore be allocated in the budget for consideration in future years.
