### R185/08/09 PLANNING, TRANSPORT, PARKING & PATHS

- a) Dedication of Fountain Members considered a request for the fountain in Castle Gardens to be dedicated to the memory of Dr David Lloyd MBE. Members were in total agreement that Mr Lloyd was a very important figure in Ludlow and deserved to be publically recognised as such. During their discussion members decided that the fountain could have a strong connection with a number of former mayors due to the very sad circumstance of the deaths of two former majors in a very short period of time, and including the original benefactor, so it might therefore be problematic to try to dedicate it to only one former mayor. Members decided that a protocol needed to be established through discussion with a wide range of community organisations including Town Council. Members also suggested ways in which Dr Lloyd could be commemorated such as an educational prize, which they thought would be very fitting memorial to a man who gave so much to Ludlow. Members RESOLVED that their recommendations should go to full Council, and a letter from the Town Clerk sent be to Mrs Hall.

### **10. REPRESENTATION**

**May Fair** – Members NOTED correspondence relating to May Fair. Members were clear that the existence of the May Fair is not in question, merely the form that the fair takes. Town Council has been left with a deficit and currently there is no valid contract in place.

Cllr made the following recommendations for Services Committee meeting on 13<sup>th</sup> July 2009:

- Full discussion of the financial situation with supporting documentation and a mind to possible resolutions needs to take place, so that the May Fair can be put a a sound legal and financial footing.
- Review the format and the current footprint of the May Fair, and work up a specification that would be suitable for the centre of Ludlow.
- c) Monument Regulations Cllrs considered the monument application as submitted and decided to uphold the current regulations, and therefore decline the application.
- d) Additional item Pigeon Problem Cllr Jackson raised the issue of problematic pigeon sin Ludlow, especially around castle gardens. Cllr Jackson had engaged children of Ludlow C of E School in a computer based competition to design an educational poster to combat the problem. Cllrs viewed the designs and selected a 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place. Cllrs were impressed by the high level of skills and imagination demonstrated by all the children.
