A resident of Mill Street, Ludlow

The resident made representations regarding the detrimental impact of planning

application **11/01560/FUL**. The resident had won a heritage award for conservation work to his house, which neighbours Cromwell House. The conservation work included the installation of a roof light to bring sun light and air into the property. The resident believed that the proposed application will be over dominant and cause his house to be put into near permanent shade, which will adversely affect the fabric of the building.

John Nash, Ludlow Civic Society

Mr Nash voiced his support for the opposition to application 11/01560/FUL and commented that the location of the bus stop in Corve Street needed to be looked at again.

Rosanna Taylor-Smith, Shropshire Councillor

Mrs Taylor-Smith congratulated Cllr Wilcox on becoming Deputy Mayor

She commented that concern had been expressed about the proposed siting of the bus shelter in Corve Street

Cllr Taylor-Smith also explained that the changes to waiting and parking in the Linney were in response concerns expressed by Violia.

She also commented that the extension to the taxi rank could cause problems for access in Tower Street.

11/01560/FUL Cromwell Cottage, 18 Bell Lane, Ludlow Objection Members consider the proposed development will be overdevelopment and overbearing in its impact on neighbouring properties and detrimentally affect the amenity of the courtyard in a way that is un-neighbourly. The height of the proposed extension will overshadow the neighbouring building causing significant loss of light to the stair well. The loss of sunlight and the heat of the sun may have a detrimental effect on the fabric of the neighbouring historic building. A neighbouring chimney will also be shaded by the height of the building which may inhibit the flow of air and therefore the draw of the wood burner using this chimney.
