R/122 PUBLIC OPEN SESSION (15 minutes)

There were five members of the public present

Mr Rosenbaum, Linney House, Linney - 12/02275/FUL

Mr Rosenbaum stated that there were two aspects regarding this application which concerned him. The first was the location of the four proposed dwellings in garden space which he understood was in a conservation area as were the trees and hedges. He pointed out that it was not only a conservation area but also a wildlife corridor with the Linney on one side and St Leonard's on the other. These dwellings he felt would not add to the conservation area. The second aspect he highlighted was that of flooding as the area had been flooded in 2002. He outlined that the applicant had stated that it was not in a flood plain but the Environment Agency had shown that the area did flood.

The Chairman stated that this application had been discussed at the Ludlow Conservation Area Advisory Committee prior to the Representational Committee tonight and that it would discussed at a future Representational Committee meeting of the Town Council.

Rosanna Taylor-Smith – Unitary Councillor

Councillor Taylor-Smith apologised for the confusion which had been created by herself attending multiple meetings.

Pamela Thompson - Linney - 12/02275/FUL

Ms Thompson explained that she was worried of the proposal to fell 67 trees as the area was a developing eco system. She was surprised that only one bat had been seen by the Conservation Officer as normally there were many at dusk. She stated she felt that the trees were a haven for wildlife and mammals. She went on to say that she felt that the proposed buildings were not in keeping with the surrounding buildings and access problems would occur in the bend by the Churchyard. She advised the Committee that she was also concerned that the wall would be lowered.

Steve Heavons - Linney Resident - 12/02275/FUL

Mr Heavons declared that he agreed with the previous speakers and had added his comments online regarding the area being a flood plain. He also read from a set of Ludlow Town Council minutes dated 23rd June 2010, signed by Councillor Aitken, stating that the Town Council would not support any applications of buildings built on a flood plain.

Julian Taylor - Linney Resident - 12/02275/FUL

Mr Taylor asked what conservation area meant as he had moved into his property at the Linney and had been told that no building would occur in this area. Since then three houses had been built but not trees had been removed and he assumed that this would be still be the case.

Rosanna Taylor-Smith – Unitary Councillor

Councillor Rosanna Taylor-Smith stated that she would be interested in the Committee's response to the Waiting Restrictions 7b on the Agenda. She acknowledged that she was unsure on how she would comment regarding the

waiting restrictions outside Portcullis Surgery and the Co-op Supermarket as restrictions could discriminate against blue badge holders and said that possible a ban on one side of the road may be the answer. Regarding restrictions on New Road/New Street she explained that the restrictions had been requested by residents due to shoppers and visitors. Turning to the waiting restrictions on Sandpits Road, Councillor Taylor-Smith declared that Mr Burmingham had attended a Committee meeting a few weeks ago and had made representations.
