Object

For the following reasons:

It is suspected that the tree is a Nootka cypress, and is a good individual specimen. Its prominent spire of green may be regarded as sufficiently valuable to warrant a TPO to prevent its felling although this involves a significant loss of private amenity to the householder because of its overbearing presence in the garden.

To ask the County Tree Officer to inspect the possible Nootka cypress, establish its species and consider whether it warrants a TPO.

There is no objection to felling three hedging trees:

Three of the four cypresses in this application stand close together on the boundary of the rear garden and are probably overgrown hedging of little aesthetic value. The fourth is a much larger free-standing tree dominating the centre of the garden. It has a weeping form and is probably a relatively rare Nootka cypress although I have not analysed material to establish the species for certain.

Both the individual tree and the group of three are prominently visible from Starstile Meadow and across Morris Bufton's trailer yard from Gravel Hill. Their crowns break up the skyline to the east and can be regarded as contributing some public amenity in this regard. However, the group of three are neither of good form nor an unusual species.
