Market Trader's meeting Minutes (26th June 2017)

Minutes

Market Traders Committee Meeting

Guidhall, Mill Street - Monday 26th June 2017 - 5pm

Meeting commenced at 5.06pm.

Previous minutes from 27th March 2017 handed out by Wendy Woodward.

. In the absence of a Chairperson Mark Clarke Chaired the meeting using the agenda issued.

Mark made some constructive comments regarding the current arrangement of the traders committee and gave practical outline for future meetings. A summary of points made were for a more structured (less thin), specific agenda together with a representation of who was on the committee so that it could be minuted who was not in attendance.

A discussion commenced regarding the possibility of more regular meetings using the Guildhall for Traders meetings. It was agreed to follow Councils advice and all members of this newly formed committee (see traders listed present) were in agreement.

The noticeable lack of Councillors or Town Clerk was also noted at the meeting even though the date for the meeting had been agreed in March.

. **Christmas** 2017 - Thursday before Christmas falls on a 3rd Thursday and that is a regular trading day for the retail (specials) market. The Thursday before Christmas has been allocated to Local to Ludlow traders. The calendar was set by the Town Clerk and approved by the Services committee. This in turn is approved by a majority vote at Full Council meetings (next meeting 29th June)

The calendar for 2017 Christmas was approved at the last Services meeting in a 5-3 vote to accept the calendar. Mark Clarke stated that he had approved of the calendar dates at the last meeting.

PD stated that licenced traders provide considerable revenue and asked why traders weren't consulted of the fact the trading day had been given away. MW also questioned the revenue for the Thursday market before Christmas. WW clearly stated that the $1^{\rm st}$ and $3^{\rm rd}$ Thursdays were traded by the retail market and the 2nd and $4^{\rm th}$ Thursday were for the Local to Ludlow market. The decision to give away a peak trading day before Christmas was questioned.

Market Traders Committee meeting - 26th June 2017

TC outlined that the decision could be overturned in 6 months but recommended that a meeting prior to the 2018 events calendar compilation would mean market traders could have an input towards the dates.

Wi-Fi on market At the current time the availability of WiFi was deemed unnecessary to pursue as there is a lot of local wifi to use.

Promotions Regarding the closure of the A49 for a 10 day period in July, PD asked what action council had taken to contact coach companies from abroad. Mark Clarke said that there were 60 coach companies in all (not all from abroad) with a main 3 regular companies. MC felt that no matter how much promotional money would be spent advertising that Ludlow was still open, it is the one day visitors who would make the most impact. They may either divert to say Bridgnorth or come back another day.

It was discussed that the coach companies coming to Ludlow are already committed to do so and locals will possibly nip on the familiar B roads anyway. PD stated that the extra diversions may leave local shops more vulnerable because of the shortened time available to shoppers off the coach.

The limited time before road closure limits options for the council as procedures have to be adhered to which may take more time than is available.

<u>Committee formulation</u> – It was agreed to formulate a committee and unite in purpose for the next meeting which was scheduled for 7^{TH} <u>AUGUST 2017 at 5pm</u>

Representatives from Market traders committee agree that attending the Services meetings would be useful and these are every 6 weeks (next meeting Monday 17th July 7pm Guildhall)

Following your recent correspondence regarding the issue of street lighting in Castle Square, members of the Services Committee considered your comments at their meeting held on Monday 5th June 2017.

Councillors sympathised with your daughter regarding her concerns, however for reasons of security, crime prevention, provision of adequate lighting for CCTV images and reassurance for all residents and businesses decided not to reduce lighting in the area.

We have received conflicting information from Shropshire Council regarding the reported countywide review of lighting due to take place over a five year period, and so we are approaching them regarding this to seek clarification on the nature and timetable for reviewing street lighting in Ludlow.

Ms Wilding,

Thank you for your letter Please can you explain to me why the lamps immediately adjacent to residential accommodation cannot be at least shaded on the side facing the buildings? This would involve minimal work and expense eg to blank out a single pane of the lamp. It would not affect the utility of the lamp to illuminate the square, to provide sufficient light for CCTV or for any of the other reasons you cite, yet it would make an enormous difference to residents who have to put up with the present ridiculous level of lighting It has been done by the county council on other lamps in the centre of the town and there is absolutely no reason why the town council cannot do the same. Please put this to your members who I am sure are aware that the council is required in law to act reasonably when exercising its powers.

As you may know, I had agreed to meet Mr Mark Clark in the square recently to view the situation. I was there at the agreed time but unfortunately Mr Clark was unable to join me.. The light level in the square is far in excess of anything elsewhere in Ludlow. Once again I invite members to meet me at night in the square when the lights are on to see the level of the problem and to make an effort to find a reasonable solution. To inform that meeting I would also invite members to share with me their understanding of the recommended levels of lighting (lux) for a public street location like Castle Square and any information they have on actual levels in the square.

Services Committee 17th July 2017

1. <u>INTRODUCTION</u>

3 <u>TEMPORARY EXHIBITIONS</u>

3.1 ALIENS OVER LUDLOW – THE NEWSFIELD DECADE


The exhibition ran from March to May and received good press, radio & social media coverage, and attracted niche computer gaming visitors, who were delighted to discover Ludlow's heritage as an important hub for computer gaming magazines and pioneering of peer reviewing of computer games in the 1980s.

The exhibition has also featured in television programme featuring the work of Oliver Frey & Roger Kean. (APPENDIX 1)



Museum Assistants, Helen and Monty are a great team, and have worked hard to promote the temporary exhibitions, and increase the footfall of the museum.

In July, Monty participated in a large well attended schools event at Enginuity Ironbridge Museum and delivered a short talk, at the invitation of STEAM Co, on the Aliens over Ludlow; Newsfield temporary exhibit. It is wonderful that Ludlow's diverse histories are reaching a wider audience



3.2 **CELEBRATING TWENTY YEARS** of The Portable Antiquities Scheme (PAS) temporary exhibition is part of the national initiative to celebrate 20 years of the Portable Antiquities Scheme and runs from June to September.

The temporary exhibition celebrates the resident artifacts that are special to the Buttercross including the Bitterly Hoard, Pommel and filigree ring; showcases a curated metal detectorist collection; and highlights the recent work and future acquisitions by the Friends of Ludlow Museum including the Talbot, South Shropshire hoard and locket.

They worked with young college students and employed them to review the games – this vital input helped to make the magazines famous and some of the students went on to enjoy extensive publishing careers themselves.


Frey's work has been influential across many genres, Russell T Davies has frequently referenced Frey as the greatest influence on his writing - notably the 1990s channel 4 drama, 'Queer is Folk' was loosely based upon a Frey comic strip, and renowned artist David Hockney collects Frey's work.

Frey and Kean remain resident in Ludlow and continue to publish, most recently, a series of illustrated children's books on Ancient Rome, Greece and Egypt cultures.

The exhibition at Ludlow Museum at the Buttercross ties in with the publication of an illustrated book celebrating Oliver Frey's work. Ludlow Civic Society are also honouring Newsfield with a blue plaque at the site of their King Street offices.

You may wish to keep Mrs Ezard up to date. I will also blind copy in the LTC ward members incase they have been asked.

The Jubilee seat and the damaged Walls family seat have now been dismantled (which is the difficult bit) and the reconstruction work is going well with some wood left over to do the long seat back salt repair at Castle Gardens.

Basically the back and part of the left hand side of the refurbed seat, will be the Walls family seat the rest from the original jubilee seat.

I was trying to get £150 to make four seats out of the two part seats, but that was not to be, but we will have the Jubilee/Wall seat ready to fit in a few weeks time, I have some stain from other volunteer bench repairs in the town and I will buy a tube of epoxy glue myself when I get back from holls in a week or so time, this way there is no cost to the town council other than our staff time to refit. Sorry its taken so long but the volunteer effort has its time limitations and we have been re staining many of the seat this last few months to keep them in good order as we look again to the Ludlow in Bloom judging.

What is really good is the re use and recycling message which Ludlow is good at a time when budgets would limit purchasing new seats.
